Indications:

Nephrauxil is used to help your body carry out special functions in chronic kidney disease.

Functional Properties:

Kidney disease changes your need for some nutrients. because patients with kidney problems are at risk of micronutrient deficiency due to dietary restrictions and also decreased appetite.

Nephrauxil has some essential micronutrients and is effective in preventing deficiency and symptoms caused by their deficiency.

Iron

You will also need to take an iron pill or have iron given during your hemodialysis treatment if you are taking EPO. You should only take iron if your doctor orders it for you.

Vitamin C

Is used to keep many different types of tissue healthy. It also helps wounds and bruises heal faster and may help prevent infections.

B Vitamins

B complex vitamins are grouped together, but each has a different job to do. One of the important functions of vitamin B6, B12 and folic acid is to work together with EPO and iron to prevent anemia. Additional B vitamins, called thiamine, riboflavin, pantothenic acid and niacin, can also be given as a supplement. These vitamins help to change the foods you eat into energy your body can use.

Calcium

Together with vitamin D, it helps to keep your bones healthy.

Contraindications:

You should NOT take nephrauxil if you:

- Are allergic to the any ingredient of this product
